About the RTÉ Toy Show Appeal

The RTÉ Toy Show Appeal was established in 2020 to raise funds for Irish children's charities through the televised Late Late Toy Show. Since then, more than €26 million has been raised to support these charities.

The RTÉ Toy Show Appeal mission is: *Inspired by children, we work to bring the magic of the Late Late Toy Show to every child in Ireland. By funding essential support, health, wellbeing, play and creativity we aim to change children's lives for good.*

Last year \in 3.8 million was raised and distributed in 127 grants to support more than 1.1 million children and their family members all across Ireland. Thanks to the continued generosity of the Irish public, this year the Appeal raised over \in 4,900,000 which will be distributed through the RTÉ Toy Show Appeal Grant Rounds in the Republic of Ireland and Northern Ireland. Each grant round will centre around three themes:

- Addressing Essential Needs
- Improving Wellbeing
- Creativity and Play



The RTÉ Toy Show Appeal grant round will open on Monday 17th February 2025. Charities supporting children and families can apply for funding until 4pm on Friday 14th March 2025. Applicants should ensure that their organisation's governance information is up to date *before* submitting their application. More information is available below on the governance information required.

How to apply

All applications to the RTÉ Toy Show Appeal should be made through our online application form on our Grants Portal.

Addressing Essential Needs Strand

Introduction

All children and young people should thrive in their environment, no matter their circumstances. The Addressing Essential Needs Strand will ensure that children and young people have access to the essential items they need, and high quality social and educational supports to help them thrive.



Applications in this strand should focus on supporting the children and young people who are most marginalised in Irish society, including:

- Children and young people at risk of poverty and facing consistent poverty.
- Children and young people facing discrimination.
- Children and young people with disabilities, life-limiting conditions and additional needs.
- Children and young people facing and/or recovering from trauma, abuse or exploitation.

Aims

There are three main aims of the Addressing Essential Needs Strand. Applicants applying to this strand should choose <u>one</u> of the six objectives below that their project or programme will meet:

- Tackling Poverty
 - Increase the number of children who have their basic human needs met, therefore reducing the impact of poverty.
 <u>OR</u>
 - Increase the number of children receiving high quality preventative wrap around supports, empowering these children and their families.
 <u>OR</u>
 - Break the cycles of poverty by increasing the number of children accessing and remaining in education and supporting best practice models of alternative forms of education which provide the best possible opportunity for children to learn.

• Ensuring Safety

- Support the recovery of children and young people who have experienced unsafe environments or situations.
 OR
- Protect and empower children and young people to be safe online by providing high quality supports to children and young people in danger or at risk.

• Enjoying the Environment

 Ensure that all of Ireland's children and young people have access to nature and green, vibrant, healthy spaces by providing programmes that bring children and young people in the natural environment.



Additional Notes

- Projects may be to continue/scale up a current programme, or to start a new one.
- Proposals to this fund can include the proportion of staff salaries specifically related to the project. This also includes new staff salaries required to increase service provision.
- Applications can include equipment or furniture that is relevant to the project or programme.
- The small-scale development of buildings or outside spaces is eligible, but large-scale development, constructing a new building, or buying a building or land is not eligible.
- Charities are encouraged to collaborate with other organisations as part of their work. There will be one lead applicant for this application who must be eligible, but this charity may collaborate with organisations who are not eligible or who may also put in their own application.

Priorities for this Strand

The RTÉ Toy Show Appeal We anticipate that this will be a very competitive grant round so proposals that meet <u>most or all the priorities</u> below will be prioritised for funding:

- Projects that have a strongly justified need based on research or formal feedback. This should be referenced in the application.
- Projects or programmes that are centred around principles of prevention and early intervention.
- Proposals that have strongly articulated the impact of the project on the direct beneficiaries *and* wider community.
- Projects that have the potential to be sustained beyond the life of this grant.
- Projects that will include the voice and feedback of beneficiaries in its development.

For charities who are applying to the **Impact Grants Round** (see further information on the Community vs Impact Rounds below), there are additional priorities:

- Projects that show innovation.
- Proposals that have strongly articulated the impact of the project on the organisation itself and the potential systemic change as a result of the project.
- Proposals that include evaluation as a part of the project and budget.
- Proposals that outline factors that ensure the success of the project.

Ineligible organisations and projects will not be successful, so please do not apply.



Who can apply for funding?

Children and family charities working at local, regional and national level can apply for a grant in the Addressing Essential Needs strand. Children and family charities should be able to demonstrate that they work regularly with children and their families. As a guideline, charities should spend at least 60% of their time with children and families.

Community Grants Round

Organisations that have an annual income of $\leq 20,000 - \leq 500,000$ must apply for the Community Grants Round. In the Community Grants Round, grants of $\leq 10,000 - \leq 20,000$ will be awarded, and applicants should apply for funding within these brackets.

Impact Grants Round

Organisations that have an annual income of more than \in 500,000 must apply for the Impact Grants Round. In the Impact Grants Round, grants of \in 20,000 - \in 50,000 will be awarded, and applicants should apply for funding within these brackets.

Transformative Grants

Charities who are eligible for the Impact Grants Round may also choose to submit an Expression of Interest application for a Transformative Grant. This application should be to scale up the Impact Grant application. There is more information on applying for a Transformative Grant below.

- Be registered with the Charities Regulator.
- Have an annual income of €20,000 -€500,000 to apply to the Community Grants Round and €500,000+ to apply to the Impact Grants Round.
- Have up-to-date and sufficient governing documents, annual accounts and child safeguarding policies.

- Animal welfare organisations
- Proposals from individuals

Charities with local branches across the country should coordinate their application through their Head Office. Only one application per charity will be accepted.

The Transformative Grants

The Transformative Grants are an opportunity for applicants to significantly upscale their application, and to build capacity within their organisation. Children's charities with an annual income of \in 500,000 or more (those who are eligible in the Impact Grants Round) may also like to submit an Expression of Interest for a Transformative Grant.

Governance Documents:

When submitting the application, all organisations will be required to complete their organisation's profile on our Grants Portal. When you log into the Grants Portal, you will see if you need to complete your organisation's profile. As part of this, you will be required to upload digital copies of the following governance documents:

• Your Constitution or Memorandum and Articles of Association.

- This must show the mission statement or main objects of the organisation, how any donations will be used and the winding up clause.
- This document must be signed.
- For the purposes of this grant round, children and/or families should be core or central to the charitable objectives.



- A current list of your organisation's Board / Committee members and the dates they were appointed.
 - For organisations with an income of more than €100,000, copies of photo IDs from two of the Board / Committee members should also be submitted, as well as a proof of address from one of these members.
- A bank or credit union account statement header
 - This statement header must clearly show the Account Name, BIC and IBAN.
 - Please blank out any transactions, as this is purely to verify the account to pay the grant into.
 - If your organisation has a credit union account, you must supply an IBAN for your specific account. We are unable to accept applications without a unique account IBAN.
- The organisation's most recent, and previous year's signed annual accounts
 - All applicants must declare their organisation's annual income on the application form, and this will be verified in your most recent annual accounts.
 - Accounts should be from 2023 or 2024 and must be signed.
 - Organisations with an annual income of less than €100,000 may provide a Profit and Loss account for the previous year if formal financial accounts are not available.
 - Organisations with an annual income of more than €100,000 must provide unabridged and audited annual accounts.

If you do not submit the correct governance documents, your application will not be considered for funding.

Reporting requirements

All grantees will be required to submit a Progress and Outcome Report during the project. Progress reports will be due at the end of January 2026 and Outcome reports will be due in July 2026.

Where a project or budget change is required, approval from Community Foundation Ireland must be sought ahead of time.
