## Mapping the existing rich ecosystem of sustainability projects





Potential opportunities in Mayo for philanthropic funding that would add value to existing sustainability initiatives.

- Barriers to accessing funding: restricted knowledge of funding sources; lack of flexibility and continuity of funding; lack of time and resources to apply for funding; sectoral and scalar issues.
- **Funding Gaps and Opportunities:** core funding for climate hubs; capital funding and planning; funding for networks and peer to peer learning; funding for deep and responsive engagement in places; funding for scaling up.



### The potential role of philanthropy in supporting existing or new climate action work


- Capital investment

- A tool for democracy and enabler of change
- The need for a broker/convenor at county level
- Support for media work



# Key messages

- In the absence of radical national commitment on climate action, the people of County Mayo have been activated to deliver sustainability at the local level.
- There is a distinct geography to climate action in the county. There are many groups doing excellent work, but their scale of ambition and potential impact, as well as longer term sustainability, is at this moment, not matched by available human or other resources.
- Philanthropy has an important role to play in supporting climate action at many levels in a county place-based giving model if a collaborative, long term, strategic view is taken.
- Given the strong commitment to community development in the county, there is huge potential in coming together to work for a more resilient future.
