

When you choose to make a legacy gift to Community Foundation Ireland, your donation will be invested into the Foundations' endowment fund, unless otherwise directed. This is a secure long-term fund meaning that the capital amount will be untouched into the future. Our expert Investment Committee manages over €50 million of endowed funds, comprising the Community Foundation Ireland Endowment Fund, as well as private named donor funds.

Endowment is key to long-term giving

Our Endowment Fund is a powerful way to create a lasting contribution. It is a proven model of philanthropy that ensures donations can have perpetual impact. Like-minded donors pool resources and grow a fund from which returns are drawn down every year.


Each year, we distribute the returns to meet the greatest needs of our time and deliver grant-making to charities that our legacy donors wish to support. This provides sustainability to the Foundation and our many partners who rely on us for funding to drive change and impact.

Endowment funding is a strategic way to support the most pressing social issues of our time. It can support areas such as education, young people, older people, biodiversity and climate, those experiencing poverty and disadvantage and addresses those pressing issues that our communities face, now and into the future.

Donors can ensure their giving lives on beyond their lifetime, continuing to support the issues that matter most to them.

In Memoriam Gifts

You may wish to set up an In Memoriam Fund, to honour the life of someone that has passed on before you. You can leave a gift in memory of this person and through endowment fund grant-making, this person's legacy lives on for generations to come.





Leaving a Legacy Gift

Types of Legacy Gifts to choose:

Selecting the type of legacy gift you wish to leave is one of the first steps.

- Residuary Gift: A percentage of your remaining estate after family, other gifts and fees have been taken care of.
- Pecuniary Gift: A fixed sum of money.
- Specific gift: A gift of assets or shares.

Ways to leave a legacy gift

- Include Community Foundation Ireland in your Will.
 - You can name Community Foundation Ireland as the recipient charity in your will, including our name, address and charity number, alongside your area of charitable giving. Please find suggested wording here for ease of download. This offers complete peace of mind that your wishes are transparent and clear.
- Include a Letter of Wishes with your Will
 - Alongside your Will, you can write a 'Letter of Wishes'. A sample Letter of Wishes <u>here</u> for you to download. This is not a legally binding document but does place a moral obligation on your executor to follow your guidance, unless there is a valid reason why your wishes cannot be honoured. We would recommend you keep a copy securely with your Will, with your solicitor and inform Community Foundation Ireland of your wishes.
- Add your legacy wishes to your existing Community Foundation Ireland Fund Agreement

If you are an existing Fund Holder or want to set up a Fund to start your giving, we can add your legacy wishes as an amendment to your Fund Agreement. The team would be delighted to work with you to develop the optimal plan for your legacy. Our team will know your beloved causes and the Executor simply transfers the amount of your gift. Again, you would need to send a copy to your Solicitor.

These clauses and suggested wordings act as a guide and the Foundation recommends that donors work with a legal, tax or financial professional where there is any complexity around a donation.





Marian Finucane Scholarship Award

To acknowledge and remember the role of Marian Finucane in achieving social change, Community Foundation Ireland in partnership with Marian's family established a scholarship award in her name. This award supported women in challenging circumstances to access further education in Ireland.

The funding ensured that Marian's tireless work on equality and her interest in human rights as well as her commitment to women in particular was not just remembered, but passed on in way that ensured a lasting legacy.

Justin O'Brien Bursary

This bursary is named in honour of Justin O'Brien, a tireless advocate for vulnerable young people and a driving force in Irish social care reform. Community Foundation Ireland is proud to join CRAVA (Children's Residential and Aftercare Voluntary Association) and Don Bosco Care, to provide the annual award, established to support care-experienced young people in accessing and succeeding in third-level education in Ireland. This bursary celebrates Justin's legacy and builds on his unwavering belief in education as a path to empowerment.
