- This tailored, giving vehicle is ideal for those who wish to avoid the administrative burden and costs associated with grant making or setting up their own fund.
- Flexibility is central to this offer. This includes duration of investment and engagement, sharing of decision making around grantees as well as offering confidence in our due diligence processes and impact reporting.
- This option offers companies the opportunity to work with colleagues to decide the causes or issues to support, on a once off or multi annual basis.

Donate to an existing Community Foundation Ireland Fund

Supporting an existing fund is highly strategic and facilitates a collaborative and effective way for companies to give. Donations would be combined with other like-minded donors to ensure maximum impact on an issue which can reflect companies or teams values. Donations could support Community Foundation Ireland funds that support children, older people, women or the environment.

Bank of Ireland Community Fund Case Study



It does this by supporting future-facing projects which are working to develop capability or foster inclusion among under-served groups and engender systemic change.
