

## Collaborating with other Charitable Organisations

In line with a growing interest in philanthropy, there is a shift away from traditional short-term charitable giving towards a greater emphasis on strategic and considered investment over the longer term. Within Community Foundation Ireland we have a successful history of partnering with Trusts and Foundations, voluntary organisations and charitable groups and helping them to fulfil their mission and goals.

The decision to establish a trust or foundation is significant; with it comes not only a responsibility for the running of the organisation but also the responsibility to those groups and communities that receive support. Community Foundation Ireland was set-up with several goals, one of which was to help grow philanthropy in Ireland. Since Community Foundation Ireland was established, the philanthropic landscape is changing, with a number of new trusts and foundations setting up in recent years

#### **Collaboration & Connection**

We regularly work in partnership with other charitable organisations, including trusts and foundations, whether in relation to shared policy interests or co-funding of specific causes or initiatives.





#### **Identifying strategic opportunities**

### **Routes to Impact**

### Set up a Donor Advised Fund (DAF)

This tailored giving vehicle is frequently used by other charitable organisations to manage a portion or all of their grant making in particular where they have no employees and where the Trustees wish to avoid the administrative burden and costs associated with distributing charitable funds.

A Donor Advised Fund may also be a suitable vehicle in winding down an existing charity, trust or foundation and spending down or maintaining the assets according to the original charitable purpose.



#### **Donate to a Fund**

Supporting an existing fund is highly strategic and facilitates a collaborative and effective way to give.

Donations can be combined for maximum impact in supporting particular cohorts in society including Older People, Women, Young People and Children, as well as important issues such as the Environment and addressing Discrimination and Inequality

#### Leave a Lasting Legacy

Charitable organisations can set up a long-term endowed fund with us, which generates investment income. By pooling your investment with our permanent fund, we reduce your risk while optimising returns. The Board and our highly experienced Finance, Audit and Investment Committee oversee investment activity.
